



Riverlink Gift Card Promotion Terms & Conditions

The promoter is Ipswich Riverlink Shopping Centre (known as Riverlink). Corner Downs Street & The Terrace, North Ipswich QLD 4305. ABN 69 704 114 267. Phone 3294 5500.

Prizes:

A total of 5 (five) x \$500 Riverlink Gift Cards will be given as prizes at the culmination of the promotion. There will be 1 (one) x \$500 Riverlink Gift card awarded to each of the 5 (five) winners. Total prize pool: \$2,500 in Riverlink Gift Cards.

Each Riverlink Gift Card Prize has an expiry date which is written on the card. The Promoter accepts no responsibility for expired prizes and refunds will not be given in cash or kind. Riverlink Gift Cards can be redeemed at any Riverlink trader who uses an EFTPOS machine.

1. Information on how to participate in the promotion, and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. This promotion is only open to Australian residents excluding the proprietors and staff of companies involved in the production, publishing and administration of this promotion and their immediate family. Immediate family means parents, siblings, spouse, children and grandparents. Tenants means Lessees, Licensees and in the case of a corporation, their Directors.
3. The staff and proprietors of Riverlink retail tenants, and their immediate family are ineligible to enter the competition.
4. This promotion commences at 9am, 4th December 2017 (AEST) and ends at 3pm on Sunday, 24th December 2017.
5. Winners will be drawn at random on Tuesday, 2nd January 2018 and contacted thereafter.
6. To be eligible to enter in this Promotion, customers purchase a Riverlink Gift card valued at \$50 or more from the booth near Best & Less or the Riverlink Centre Management Office.
7. Riverlink gift cards purchased for less than \$50 in value are ineligible for an entry and their values cannot be added to be eligible for an entry.
8. One entry only will be given for every \$50 put on one Riverlink Gift Card of \$50 or more in value. Eg. If a customer purchases a \$75 gift card, one entry will be given. If a customer purchases a \$100 gift card, 2 entries will be given. If a customer purchases 3 x \$75 gift cards, 3 entries will be given.
9. Riverlink Gift Cards can be redeemed at any Riverlink trader who uses an EFTPOS machine.

10. The Promoter reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these
11. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any claimant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.

Except for any liability that cannot be excluded by law, the Promoter (including its officers, employees and agents) excludes all liability (including negligence) for any death or personal injury, or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim that is late, lost altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in gift value to that stated in these Terms & Conditions; (e) any tax liability incurred by a winner or claimant; or (f) use of the Gift.

The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Claims are conditional on providing this information. The Promoter may, for an indefinite period, unless otherwise advised, use the information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the claimant. Claimants should direct any request to access, update or correct information to the Promoter. All claims become the property of the Promoter.
